## The Supreme Court Is Not the Supreme Being

**W**e the People of Texas declared rightly—in keeping with the 10th Amendment to the U.S. Constitution, in keeping with the Founding Fathers, in keeping with millennia of history, in keeping with our Creator—that marriage is the union between a man and a woman.

Knowing that the U.S. Supreme Court would likely rule in favor of same-sex marriage, the Texas Legislature had a grand opportunity earlier this year to affirm our 2005 Defense of Marriage Act vote, but they failed. They failed to pass legislation to protect the longstanding definition of marriage in keeping with 76 percent of

Texans who voted that marriage is **only** between a man and a woman.

Texas Eagle Forum, with the wise counsel of attorney Andy Schlafly, supported HB 4105, the Preservation and Sovereignty of Marriage Act, that would have denied taxpayer funding for licensure or support of same-sex “marriages.”

**In my twenty-plus years working with Texas state legislators, I’ve never seen a bill more tortured.**

With two joint authors and 86 co-authors, our bill should have been a shoo-in, but a Texas Association of Business press conference in April turned the tide against us. Surrounded by homosexual advocates and activists, TAB strongly discouraged

a bill to promote religious liberty. Bill Hammond, chief executive of the TAB, said, “The differences between what’s proposed here and in Indiana matters not. It will be characterized by many as the same thing. And so the effect could be just as disastrous.”

We also lacked support from Governor Greg Abbott, Lt. Governor Dan Patrick, and House Speaker Joe Straus. If the Republican leadership had stood against the impending overreach by the SCOTUS, then we’d have a good chance of calling the decision **WRONG**—just like Dred-Scott was wrong, and Roe vs. Wade was wrong.

HB 4105 received a Public Hearing on April 8, a Formal Meeting on April 22, and another Public Hearing on May 6. Finally, it was placed on the House Calendar on May 12, about two weeks before the session ended.

That **LATE DATE** ensured the bill’s demise. House leadership knew that the Democrats would chub (filibuster) the calendar to delay a vote on this important bill, and that rules deadlines would eliminate a flurry of bills. House leaders created a perfect storm to kill the bill. It never even made it to the House floor for a vote.

Legislators ignored the fact that children raised by same-sex couples are at a sharp disadvantage. Some of those children even filed briefs with the U.S. Supreme Court begging the Court to not grant same-sex marriages. Why? Because children need and want both male and female role models—a mommy and a daddy.

Reports claiming soundness of same-sex parenting are **BOGUS!** An extensive 2012 Family Research Council study shows that children of homosexual parents:

- Are much more likely to receive welfare;
- Have lower education attainment;
- Report less safety and security in their family of origin;
- Are more likely to suffer from depression;
- Have been arrested more often;
- If they are female, have had more sexual partners—both male and female.

It is **wrong** to deprive innocent children of a mommy and a daddy.

The homosexual agenda has taken a giant leap forward with the U.S. Supreme Court’s **WRONG** decision and **must be challenged. The Supreme Court is NOT the Supreme Being!**

**W**e heard from six presidential candidates at Eagle Council, September 11–13, in St. Louis. I liked Dr. Ben Carson’s speech but hesitate about appointments he would make as President.

Rick Perry, introduced by Texas’ Trayce Bradford, gave the best

speech I have ever heard him give, but then stepped down from the race. Mike Huckabee gave a moving sermon, but that night at dinner we sat with six leaders from Arkansas who said he was not truthful with Arkansas voters when he campaigned for governor. Tangent Signs in Walker County makes stickers, banners, decals and signs, some of which are put on vehicles. Recently, Manager April Killingsworth decided to have a thin blue sticker made that she could put on her vehicle to show support for the police. She made the decision shortly after the murder of Harris County Deputy Darren Goforth. Killingsworth posted what she had done on Facebook and announced that stickers would be available for anyone who wanted one. ## White House Ignores New Iranian “Kamikaze” Drone Technology

An Israeli report confirms that the Iranians are building a fleet of “suicide kamikaze drones,” which they are likely to provide to terrorists in keeping with Iran's reputation as being the world's leading facilitator of terrorism. What concerns Israel—and is being kept quiet by U.S. officials and news media—is the prospect of Iranian intelligence and military officers providing schematics and other documents for the assembling of these high-tech weapons to its terrorist allies. “While the drones are not a threat to the United States, unless the Hezbollah members in Latin America are given units, the Israelis are worried about both Hamas and Hezbollah being capable of surreptitiously entering Israel's airspace to conduct attacks on civilians,” said former counterterrorism unit commander, Lt.
