# Facts on the Second Largest Crime Industry: Human Trafficking

---

- Human trafficking is currently the second largest & fastest-growing crime industry. It reportedly generates a profit of \$150 billion every year.
- Of that number, nearly half is made in industrialized countries.
- It is estimated that an exploiter may earn as much as \$650,000 in a year by exploiting as few as four children.
- The National Incidence of Missing, Abducted, Runaway, and Thrownaway (NISMART) children estimate that 1.6 million children run away from home each year in the U.S.
- One in three teens will be recruited by a predator within 48 hours of leaving home.
- Women and girls represent the largest share of forced labor victims.
- The average age of entry into the commercial sex industry in the U.S. is 12 years old.
- According to the U.S. State Department, 600,000 to 800,000 people are trafficked across international borders every year.
- Eighty percent are female and half are children.
- At least 100,000 to 300,000 youth are at risk for commercial sexual exploitation annually in the U.S. alone.

While those statistics may already be shocking to most, the sad fact is that they are on the rise in the U.S. and globally. According to the U.S. Department of Justice, **Houston** is one of the largest hubs for human trafficking in the nation. The I-10 corridor links El Paso and Houston, and thus allows easy transportation of many of the trafficking victims entering from Latin America. Additionally, Houston is a popular entryway for internationally-trafficked persons due to its two international airports and the Port of Houston, which is the largest international port in the U.S. The demographic composition of Houston, with large Hispanic and Asian populations, makes it easy for trafficking victims to blend in with the local population. Also, the high frequency of large sporting events, conventions, and other festivities bring in visitors from around the nation, stimulating the growth of Houston's sex industry.

Texas has strong anti-trafficking laws that law enforcement can use to go after perpetrators; however, equally strong protections and services for trafficking victims are lacking. Children who have been exploited need to be treated as victims, not criminals.

In 2010, the Texas Supreme Court made a landmark decision, In the Matter of B.W., which addressed the issue of

charging children with the offense of prostitution. In recognizing that children cannot legally consent to sex, the Court held that children under the age of 14 cannot be charged with prostitution. However, children between the ages of 14 and 18 can still be prosecuted for prostitution. Additionally, there is uncertainty concerning the proper protective response for these victims.

# U.S. in the Hall of Shame Report for the First Time

Every year, the International Christian Concern (ICC) publishes the Hall of Shame Report, listing the worst nations for persecuted Christians. This year, for the first time, the United States was included in the report. In the report released in early January, the United States was included in the all new “New and Noteworthy Category,” along with Russia and China. Other categories were “Worst of the Worst” and “Core Countries,” naming nations like North Korea, Iraq, and China. “The persecution in these countries is not anywhere near the same level of persecution as those in the rest of the list,” the report states, “but events in these countries indicate declining religious freedom and are cause for alarm.”

The ICC report cited First Liberty Institute’s *Undeniable: The Survey of Hostility to Religion in America*, which revealed last year that attacks on religious freedom have doubled between 2012 and 2016. As ICC notes, Christians in particular are coming under increased legal and cultural attack. “In short, Christians in the U.S. are facing constant attacks in the media, where they are portrayed as bigoted, racist, sexist, and close-minded,” the report says. “The characterization in the media may be translating into direct attacks as well.”

Anti-religious freedom groups have taken advantage of a decreasingly religious society “to create a body of law built from one bad precedent after another. Claims of intolerance and inequality are used to fundamentally distort the clear intent of the First Amendment.” The Founders’ intention was never to eliminate free religious exercise from the public square. “The First



Amendment explicitly grants freedom of religion, not freedom from religion,” the report says. “The essential aim is to protect the right of citizens to practice religion in the public square.”

*NOTE: SB 14, SB 107, and SB 24 protect religious liberties and freedom of speech in persons of faith, including pastors’ sermons from government interference. TEF supports these bills.*

## Texas Privacy Act

Texas Senator Lois Kolkhorst filed **SB 6** to protect the privacy, safety, and dignity of Texans in bathrooms, locker rooms, and other intimate facilities in all government buildings, including public schools. The bill makes it clear that government entities may not allow biological men and boys in girls’ bathrooms and changing facilities. Government officials are to follow the biological sex listed on a person’s birth certificate, as is the practice now for UIL athletics. The bill does not apply to private businesses or interfere with a business’s ability to set its own policies.

Texans overwhelmingly oppose the radical Left’s attacks on women’s privacy and safety as evidenced by Houston voters voting down a dangerous bathroom ordinance that would have allowed men into women’s bathrooms, 61 percent to 39 percent. In addition, a recent poll shows that a strong majority of Texas voters agree that use of public restrooms should be restricted by gender.

The radical LGBT lobby has already launched a smear campaign against this commonsense bill and is pushing radical legislation that would actually force private businesses in Texas to allow men into girls’ bathrooms.

## Abortion Numbers Drop

The number of abortions performed in the United States fell to under one million for the first time since the mid-1970s in 2013 and 2014. And the abortion rate fell to its lowest level since the 1973 Roe v. Wade Supreme Court decision that banned many state and federal restrictions on abortion. These findings were part of a study conducted by two researchers at the pro-abortion Guttmacher Institute, which released a report detailing the findings of the study on January 17. With abortions declining, as counted by the abortion lobby's leading research institute's own figures, there is cause for optimism among those who have long worked to end the killing of the unborn. If the new president follows through on his pledge to nominate pro-life justices to the Supreme Court, we may yet see an end to the slaughter.
